


## Study: "Dreamscrolling" Time & Possible Benefits

A <u>survey of 2,000 Americans</u> showed that survey participants "dreamscroll" (look at dream purchases or things they'd like to own one day) for an average of 2.5 hours each day. 71% of survey participants said "dreamscrolling" is time well spent and motivates them to reach their financial goals. Homes, vacation destinations, beauty or self-care products, pets, furniture, gadgets, and clothings were the top things "dreamscrolled."

## **Utility Bills to Reach Record High**

The <u>National Energy Assistance Directors Assoc.</u>
(NEADA) forecasts that utility bills will increase by 8% from June to Sept. compared to last year. NEADA also

reports that summer cooling costs have risen from an average cost of \$476 in 2014 to \$719 in 2024. For Wisconsin, NEADA forecasts costs to increase by 10% in summer 2024. Currently, Wisconsin is one



# Research on Debt Used to Pay for Groceries in 2023

The <u>Urban Institute has released a report</u> focused on data from its 2023 Well-Being and Basic Needs Survey, which centers on how families used credit cards, payday loans, and buy now, pay later (BNPL) loans to pay for groceries. According to the report, about 70% of all grocery transactions are paid for with credit or debit cards. Of those users, about 45% either didn't pay their credit card bill in full or didn't make a


minimum payment. Moreover, 3.5% of adults reported using BNPL to pay for groceries. Of those who used BNPL to pay for groceries, 37% missed a payment on their BNPL loan.



## **Student Loan Debt Among Older Workers**

New research from the Schwarz Center for Economic Policy Analysis details how student loan debt can impede the financial security of older workers. Research estimates there are 2.2 million people over the age of 55 with outstanding student loans. Workers aged 55+ and in the middle income brackets represent the highest proportion of all student loan borrowers. On average, workers aged 55-64 expect to take an average of 11 years to repay their loans. The report concludes that 2 reforms would enable older workers with student loan debt to save for retirement: the SAVE Plan and ending the garnishment of Social Security benefits to repay student loans--which 30 members of Congress called on in March 2024 in a letter to the leadership of the Social Security Administration and U.S. Department of the Treasury.





## IRS to Expand 'Direct File' Program in 2025

On May 30, the U.S. Dept. of the Treasury and the Internal Revenue Service (IRS) announced that 'Direct File', a free federal tax filing system from the IRS, will be made permanent and offered to all U.S. states in 2025. In 2024, the program was available to residents of just 12 states. It is not yet known how state officials will respond to the offer to join the program.

## What is Developmental Screening?

It's important we want our children to grow up and develop healthy. And it's common parents may have concerns whether their child is developing appropriately for their age group. Developmental screenings is one of the tools that can help you determine if your child is developing on track for his or her age. It's a way to see if there might be any concerns in how your child learns, plays, speaks, or behaving. You can ask your child's doctor, childcare provider/teacher, or home visitor about doing a developmental screening.

Below are some developmental milestones you might notice in young children:

- Age 3 able to dress and undress themselves, follow simple instructions, fine controlled motor skills, able to name some colors and identify simple objects like shapes and animals, play make believe, speak 5-6 word sentences
- Age 4 enjoy playing with other children, well balanced and stable physical abilities like jumping or hopping on one foot, sing songs, express and communicate simple emotions (ex. happy, sad, mad)
- Age 5 able to say full names, take turns playing, well-developed physical motor skills like holding scissors or riding a bike, count to 20, and draw a full bodied person

## **FUN FACT - FIREWORKS for July 4th**

Fireworks originated in China about 2000 years ago, made out of charcoal, sulfer and potassium nitrate inside a bamboo tube. Overtime, it was used for various ceremonies and rituals. The earlies documented use of fireworks in England was at the wedding of King Henry VII in 1486. In 1777, America used fireworks as part of Independence Day. In the 1800s, Italians discovered how to add color to fireworks by using small amounts of metal mineral and salts. Today, China is still the world's largest manufacturer and exporter of firework, producing 90% of all fireworks.
